RE: APPLICATION FOR NOMINATION TO PCEA KAYOLE NWD T SACCO BOARD/ SUPERVISORY COMMITTEE MEMB

Following the adoption of our by-laws and subsequent registration by the commissioner of cooperatives, we hereby invite interested members to apply for the above nominations.

ELIGIBILITY FOR MEMBERSHIP TO THE BOARD OF DIRECTORS AS PER THE SACCO BY-LAWS.

- i) **MUST** have been a member of the SACCO for at least **three (3)** years prior to the close of the financial year in which the Annual General meeting relates.
- ii) **MUST** have attained a minimum of **Kshs. 500,000** in non-withdrawable deposits and **Ksh. 12,000** in share capital prior to the close of the financial year in which the Annual General meeting relates.
- iii) **Must have duly completed the nomination forms together with Fit and proper test forms**
- iv) **MUST** have attained a minimum of "O" level certificate of Education
- v) **MUST NOT** have been in delinquent on any loans with the Sacco for more than **60 days** within 2 years prior to the AGM.
- vi) **MUST NOT** be an official or holds a political office at any level.
- vii) **MUST NOT** be a board Member of another existing SACCO society licensed under the SACCO Society Act.
- viii) **MUST NOT** have been charged of any offence involving dishonesty, a crime involving fraud, perjury or breach of contract of a financial institution.
- ix) **MUST NOT** have been adversely named by the Authority in an inspection report for management or corrupt practices whilst st a member of a Sacco Society.
- x) **MUST NOT** have been removed from public office or barred from holding public office by any agency of the government, on disciplinary action.
- xi) **MUST** adhere to the chapter 6 of the Kenya constitution and avail the following:
 - Copy of national Identification
 - Valid KRA pin certificate
 - Valid certificate of good conduct
 - Clearance certificate from Ethics and Anti- Corruption commission
 - Clearance certificate from Credit Reference Bureau
 - A Curriculum Vitae indicating education / professional qualifications and key positions held in other organizations/ institutions (past / current)
